NO VEHICLES WILL BE ALLOWED BEHIND YOUR BOOTH.

Checkout will take place at the event end on Sunday, July 4 no later than 12:00 p.m. At that time, all remaining booths will be disconnected from electrical services. You are responsible for cleaning your area of trash and placing trash in the proper containers.

Indemnification and Agreement

The Vendor agrees to accept full responsibility for the quality of any and all goods sold by the vendor and the vendor's organization at the 2022 United Bikerz/FHO Jamboree. Vendor agrees to be open during all event hours on all days of the event. **Exhibitor/Vendor will be responsible for any and all costs associated with setting up your booth, including, but not limited to, display surfaces and clean-up. Only the space will be provided.**
